**JOINDER AND COMPLAINT – DEFAMATION ACTION**

NOW COMES the Plaintiff, District Attorney Joshua Lamancusa, Esquire, and hereby files this Joinder and Complaint in Defamation, respectfully stating as follows:

1. The Plaintiff, District Attorney Joshua Lamancusa, of Lawrence County, is the duly elected District Attorney of Lawrence County.
2. The Plaintiff, District Attorney Joshua Lamancusa, of Lawrence County, has a residential address within Lawrence County and maintains an office address of 430 Court Street, New Castle, PA 16101.
3. The Defendant, Diane Stickle Berkebile, of Lawrence County, is currently residing within Lawrence County with a residential address of 142 East Garfield Avenue, New Castle, PA 16105.
4. On August 19, 2022, a Complaint alleging defamation was filed at Case No. 10680 - 2002, C.A., by Plaintiff Denise M. Slagle, Plaintiff, vs. Diane Stickle Berkebile, Defendant.

5. The above referenced complaint, filed at Case No. 10680 - 2002, C.A., contains numerous allegations of defamatory behavior committed by the Defendant against Plaintiff Denise M. Slagle and others, and a hearing has been scheduled for November 16, 2022 @0930 before the Honorable John W. Hodge.
6. Within Plaintiff Denise M. Slagle's Complaint, there are numerous allegations and dozens of attachments of social media postings by the Defendant alleging a plethora of defamatory statements, including ones of a criminal nature. The Defendant's defamatory allegations are made against Plaintiff Denise M. Slagle, District Attorney Joshua Lamancusa and an ever-expanding list of government, public and private individuals.
7. Plaintiff Denise M. Slagle's claims and supporting documentation contained in the above referenced complaint, filed at Case No. 10680 - 2002, C.A., are attached hereto and incorporated in Plaintiff District Attorney Joshua Lamancusa's Joinder and Complaint – Defamatory Action.
8. At the time of the commission of the acts mentioned within this document, Plaintiff was, and still is, a resident of Lawrence County, Pennsylvania. Plaintiff was and is the duly elected District Attorney of Lawrence County, and has always enjoyed the respect, confidence, and esteem of the people of Lawrence County.
9. Defendant falsely, maliciously, and illegally made and published, and continues to make and publish, false, scandalous, illegal, defamatory, and malicious statements about Plaintiff's private life, family and actions as a public official.
10. Defendant made such statements knowing they were not true, with the intent to injure Plaintiff and to deprive Plaintiff of his good name. Defendant further intended to cause

Plaintiff to be removed from Public Office based upon these false, scandalous, illegal, defamatory, and malicious statements.

11. Defendant made and continues to make such defamatory statements utilizing social media accounts, numerous social media groups and forums, internet podcasts and Youtube productions. These defamatory statements have been published and disseminated to the general public.
12. Attached are a small sampling of the hundreds of public postings made by the Defendant that are false, scandalous, illegal, defamatory, and malicious in nature, and are hereby incorporate by reference.
13. The statements and postings made by the Defendant in the attached writings against Plaintiff are false.
14. Defendant knew at the time of posting that the statements and postings were untrue.
15. Defendant maliciously and wantonly, with intent to injure Plaintiff at the time of the creation and posting of the attached representative sample, did disseminate these postings to the general public.
16. Specifically, Defendant alleges that Plaintiff is the "mastermind" behind a convoluted scheme to target, incapacitate, and kill her mother for some claimed economic benefit. Defendant also alleges that Plaintiff raped and drugged her mother with the assistance/acquiescence of the Attorney General of Pennsylvania, doctors, numerous judges, government officials, legislative public officials, and private citizens. Defendant also alleges that Plaintiff continues to target members of the community to steal their assets and incapacitate their family members, as well as threatening and intimidating local officials to engage in a cover up of purported illegal activity. Defendant also

alleges that Plaintiff is involved in a wide variety of criminal enterprises including theft, conspiracy and obstruction of justice.

17. The statements of the Defendant, some of which are identified above and attached to this Complaint, were made intentionally, willfully, and maliciously, and were made with her knowledge of their falsity and/or with reckless disregard for their truth or falsity.

18. As a result of Defendant's malicious and false statements, Plaintiff has suffered and continues to suffer injury to his name and reputation.

WHEREFORE, Plaintiff respectfully requests that this Honorable Court join this action with the case filed at Case No. 10680 - 2002, C.A., as they relate to the same matters and contain identical allegations and evidentiary proof.

WHEREFORE, Plaintiff respectfully requests that this Honorable Court enter judgement against Defendant for general and special damages in excess of \$100,000 according to proof, general, punitive damages, costs of suit and any other relief that this Court may deem just and proper.

#### **PRELIMINARY INJUNCTION**


19. Plaintiff incorporates all of the above averments and attachments herein.

20. Defendant continues to post, almost daily, false, misleading, malicious, and defamatory social media postings about Plaintiff without regard to the truth and/or with a reckless disregard for the truth.

22. Defendant's continuous postings and dissemination to the general public are damaging to the reputation of the Plaintiff as an elected official within and outside of Lawrence County, Pennsylvania.

24. No prior action for injunction has been requested and no bond is required when filed by a district attorney.

**PETITION FOR SPECIAL RELIEF**

NOW COMES the Plaintiff, District Attorney Joshua Lamancusa, Esquire, and hereby files this Petition for Special Relief, respectfully stating as follows:

**I. PROCEDURAL HISTORY**

1. Plaintiff filed a Defamation Complaint and Petition for Injunction at the above case number on November 8, 2022, against Defendant Berkebile.
2. Service of the above referenced filing was attempted on numerous occasions by the Lawrence County Sheriff at the residence of Defendant Diane Stickle Berkebile. Defendant Berkebile refused to answer the door during each of the Sheriff's attempts of service, despite being home and looking out the window. See Exhibit A. Sheriff's Return.
3. Pennsylvania Rule of Civil Procedure 430 provides that: (a) If service cannot be made under the applicable rule the plaintiff may move the court for a special order directing the method of service. Rule 430. Service Pursuant to Special Order of Court.

4. Plaintiff seeks this Honorable Court's permission to serve in an alternative means as clearly the Defendant is aware of the Complaint and actively avoiding service thereupon.

## II. FACTUAL HISTORY AND LEGAL CAUSE OF ACTION

5. The Plaintiff, District Attorney Joshua Lamancusa, of Lawrence County, is the duly elected District Attorney of Lawrence County.
6. The Plaintiff, District Attorney Joshua Lamancusa, of Lawrence County, has a residential address within Lawrence County and maintains an office address of 430 Court Street, New Castle, PA 16101.
7. The Defendant, Diane Stickle Berkebile, of Lawrence County, is currently residing within Lawrence County with a residential address of 142 East Garfield Avenue, New Castle, PA 16105.
8. On August 19, 2022, a Complaint alleging defamation was filed at Case No. 10680 - 2002, C.A., by Plaintiff Denise M. Slagle, Plaintiff, vs. Diane Stickle Berkebile, Defendant.
9. The above referenced complaint, filed at Case No. 10680 - 2002, C.A, contains numerous allegations of defamatory behavior committed by the Defendant against Plaintiff Denise M. Slagle and others, and a hearing has been scheduled for November 16, 2022 @0930 before the Honorable John W. Hodge.
10. Within Plaintiff Denise M. Slagle's Complaint, there are numerous allegations and dozens of attachments of social media postings by the Defendant alleging a plethora of defamatory statements, including ones of a criminal nature. The Defendant's defamatory

11. Plaintiff Denise M. Slagle's claims and supporting documentation contained in the above referenced complaint, filed at Case No. 10680 - 2002, C.A., are incorporated in Plaintiff District Attorney Joshua Lamancusa's Joinder and Complaint – Defamatory Action.
  12. At the time of the commission of the acts mentioned within this document, Plaintiff was, and still is, a resident of Lawrence County, Pennsylvania. Plaintiff was and is the duly elected District Attorney of Lawrence County, and has always enjoyed the respect, confidence, and esteem of the people of Lawrence County.
  13. Defendant falsely, maliciously, and illegally made and published, and continues to make and publish, false, scandalous, illegal, defamatory, and malicious statements about Plaintiff's private life, family, and actions as a public official.
  14. Defendant made such statements knowing they were not true, with the intent to injure Plaintiff and to deprive Plaintiff of his good name. Defendant further intended to cause Plaintiff to be removed from Public Office based upon these false, scandalous, illegal, defamatory, and malicious statements.
  15. Defendant made and continues to make such defamatory statements utilizing social media accounts, numerous social media groups and forums, internet podcasts and YouTube productions. These defamatory statements have been published and disseminated to the general public.
  16. Attached are a small sampling of the hundreds of public postings made by the Defendant that are false, scandalous, illegal, defamatory, and malicious in nature, and are hereby incorporate by reference.

17. The statements and postings made by the Defendant in the attached writings against Plaintiff are false.
  18. Defendant knew at the time of posting that the statements and postings were untrue.
  19. Defendant maliciously and wantonly, with intent to injure Plaintiff at the time of the creation and posting of the attached representative sample, did disseminate these postings to the general public.
  20. Specifically, Defendant alleges that Plaintiff is the "mastermind" behind a convoluted scheme to target, incapacitate, and kill her mother for some claimed economic benefit. Defendant also alleges that Plaintiff raped and drugged her mother with the assistance/acquiescence of the Attorney General of Pennsylvania, doctors, numerous judges, government officials, legislative public officials, and private citizens. Defendant also alleges that Plaintiff continues to target members of the community to steal their assets and incapacitate their family members, as well as threatening and intimidating local officials to engage in a cover up of purported illegal activity. Defendant also alleges that Plaintiff is involved in a wide variety of criminal enterprises including theft, conspiracy, and obstruction of justice.
  21. The statements of the Defendant, some of which are identified above and attached to the original Complaint filed in this case, were made intentionally, willfully, and maliciously, and were made with her knowledge of their falsity and/or with reckless disregard for their truth or falsity.
  22. As a result of Defendant's malicious and false statements, Plaintiff has suffered and continues to suffer injury to his name and reputation.

WHEREFORE, Plaintiff respectfully requests that this Honorable Court join this action with the case filed at Case No. 10680 - 2002, C.A., as they relate to the same matters and contain identical allegations and evidentiary proof.



  27. Defendant's continuous postings and dissemination to the general public have caused and continue to cause immediate and irreparable injury to the Plaintiff's reputation.
  28. No prior action for injunction has been requested and no bond is required when filed by a district attorney.

WHEREFORE, Plaintiff respectfully requests that this Honorable Court preliminarily enjoin the Defendant from any future social media postings related to the allegations hereto referenced pursuant to Rule 1531 of the Pennsylvania Rules of Civil Procedure, until such time as a preliminary hearing can be held if requested by the Defendant. 



8. These violations of the current Order of Court are without cause, willful, intentional, deliberate and without justified excuse.



NOW COMES the Plaintiff, District Attorney Joshua Lamancusa, Esquire, and hereby files this Petition to Supplement Civil Contempt Hearing, respectfully stating as follows:

1. On March 1, 2023 a Civil Contempt Hearing was conducted without the presence of the Defendant, despite multiple attempts to serve Defendant notice.

WHEREFORE, Plaintiff respectfully requests that this Honorable Court hold Defendant in Civil Contempt and impose the following sanctions upon the Defendant:

Based upon the evidence presented by the Plaintiff on January 10, 2023, the Preliminary Injunction entered by the Court on December 14, 2022, was made a permanent injunction. The January 10, 2023 Order of Court was as follows:

"The Court finds that the Plaintiff has presented substantial evidence that the social media postings made by the Defendant concerning the Plaintiff, are outrageous, blatant falsehoods, and totally lacking in any truth or substance.

As a result, the Court grants the Plaintiff's Request for Special Relief and an Injunction is hereby entered in favor of the Plaintiff against the Defendant, whereby the Defendant is hereby directed to remove any and all allegations concerning the Plaintiff contained in all social media sites, and the Defendant is hereby permanently enjoined from any future social media postings relative to the Plaintiff and the outrageous allegations, blatant falsehoods, and other postings totally lacking in any truth or substance."

On March 1, 2023, the Plaintiff presented evidence that the Defendant has not complied with the Order of Court of January 10, 2023, and that to the contrary, she has proceeded to post on almost a daily basis, comments, podcasts or other statements, accusing the Plaintiff, District Attorney Joshua Lamancusa, of kidnapping, murdering her mother, and other totally irrational and undoubtedly false statements about the Plaintiff, which defamatory statements have caused the Plaintiff and his family great emotional distress.

The Defendant, Diane Stickle Berkebile, despite being served with the Plaintiff's complaint in accordance with the Pennsylvania Rules of Civil Procedure, has not responded to the Court petitions, motions or complaints in any manner, nor has the Defendant engaged legal counsel to appear on her behalf.

The statements which the Defendant has posted on the various social media sites are totally defamatory, malicious, totally inaccurate, untrue, and serve no purpose other than to cause deep emotional distress to the Plaintiff, for no cause whatsoever.

As a result, based upon the testimony presented at the March 1, 2023 contempt hearing, the Defendant is determined to be in civil contempt of this Court's Order of January 10, 2023.

As a sanction for the Defendant's violation of the Order of this Court dated January 10, 2023, the Court imposes the following sanctions upon the Defendant:

The Defendant may purge herself of the sanctions imposed for the violation of the Court's Order of January 10, 2023, by doing the following, and by filing of record no later than April 10, 2023, an Affidavit of Compliance with the following conditions:

1. By removal of all social media posts, including any written or oral statements of any kind or nature, in any podcast or social media forum, including but not limited to

Facebook, Tic Toc, Twitter, Instagram or other social media or any other public forums about or referencing in any manner to District Attorney Joshua Lamancusa.

2. By entering into a payment agreement with the County of Lawrence, through the Office of the Prothonotary, of a fine in a reduced sum of \$500.00.





**I. HISTORY**






3. In addition, it is alleged that the Defendant has failed to report to the Lawrence County Correctional Facility in compliance with the Order of Court dated March 23, 2023.

**ORDER OF COURT**

**AND NOW**, this 22<sup>nd</sup> day of May, 2023, this case being scheduled before the Court this date for a hearing on a Petition of Noncompliance, with the Plaintiff, District Attorney Joshua Lamancusa, appearing pro se, and Defendant, Diane Stickle Berkebile, not appearing.

1. This hearing was scheduled pursuant to Order of Court dated April 24, 2023. The Order was served on the Defendant by U.S. Certified Mail and regular U.S. Mail, both of which were exited from the Office of the Prothonotary of Lawrence County, Pennsylvania, on April 25, 2023.

2. The regular U.S. Mail was not returned to the Office of the Prothonotary.

3. The U.S. Certified Mail was returned to the Office of the Prothonotary of Lawrence County, after the U.S. Postal Service attempted to serve the Defendant with the mail on April 27, 2023, May 2, 2023, and May 12, 2023.

4. The Order of Court of April 24, 2023, as entered on the Plaintiff's Petition for Noncompliance, alleged in Paragraph No. 3 that the Defendant has failed to report to the Lawrence County Correctional Facility in compliance with this Court's prior Order of March 23, 2023; and in Paragraph No. 4, a Rule to Show Cause was entered upon the Defendant to show cause why a Bench Warrant should not be issued for her immediate

incarceration, due to the Defendant's willful and intentional failure to comply with prior Orders of this Court, dated March 23, 2023, as supplemented on April 18, 2023, with the Rule being returnable by way of written response on or before May 12, 2023.

5. The Court was in receipt of a Delayed Sentence Form from the Lawrence County Correctional Facility, dated April 21, 2023, indicating that the Defendant did not report to the Lawrence County Correctional Facility as required by the prior Order of this Court.

6. In addition, the Defendant failed to file a written response to the Rule to Show Cause issued by this Court pursuant to Order of April 24, 2023.

7. In addition, the Plaintiff advised the Court that following the last Order of Court, and within several days prior to the hearing this date, that the Defendant had made approximately 20 posts, which were shared hundreds of times, accusing the Plaintiff of the same course of conduct relative to Defendant's mother, namely, stealing her fortune and assaulting her.

8. The Court finds that the Defendant has been provided with the essential due process prerequisites for a finding of civil contempt of notice and an opportunity to be heard before the Court. In addition, the Plaintiff has provided evidence of Defendant's noncompliance of the prior Orders of this Court finding her in contempt of the prior Orders of this Court, and that the Defendant has failed to purge herself from the civil contempt sanctions as previously imposed by this Court.

9. In that the Defendant has failed to avail herself of the opportunity to appear for the court hearings and to provide an explanation to the Court for her continued




defamation, liable and slander of the Plaintiff, both personally and professionally in the performance of his duties as the duly elected District Attorney of Lawrence County, Pennsylvania, and with the Defendant's failure to exercise her right to purge herself of the Civil Contempt of Court Order and Sanction Orders previously filed in this matter, and with the Court being advised of the Defendant's continued violations of the prior Order of this Court, this Court has no other recourse available to coerce the Defendant into compliance with the prior Order of this Court other than to grant the Plaintiff's Motion for Issuance of Bench Warrant for the arrest of the Defendant in this matter.

10. As a result, it is the Order of this Court that a bench warrant shall be issued for the arrest of the Defendant, Diane Stickle Berkebile.

11. 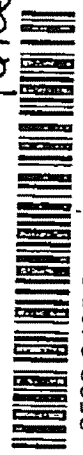
